### 3. General Conditions of the Bid:

- 1. Incomplete and late bids will not be entertained and will be liable to be rejected.
- II. Bidders shall be responsible for Delivery/Completion of work as per specification and size intimated by the Lalit Narayan Mithila University, Kameshwaranagar, Darbhanga, Bihar from time to time.
- III. A Demand Draft of ₹10,00,000/- (Ten Lakh Only) in favour of Registrar, Lalit Narayan Mithila University, Kameshwaranagar, Darbhanga, Bihar payable at Darbhanga should be submitted towards Earnest Money alongwith Bid. Bids without EMD will not be entertained. The successful bidder's EMD will be converted into Security Deposit upon bidder's acceptance of award of work. Which will form part of Performance Security @10% of Total value of work to be done.
- IV. Bidder's Security Money may be forfeited:
  - (a) If the bidder withdraws his bid during the period of bid validity specified in contract/agreement.
  - (b) If the successful bidder fails to sign contract/agreement within 03 days of issue of letter of intent.
- V. The prices must be quoted in the format as specified in the tender document, and should be inclusive of packing, forwarding, insurances, delivery at sites, duties and taxes.

### 4. Special Conditions of the Bid:

- The sealed envelopes (separate for should be titled as "INVITATION OF BID FOR CONFIDENTIAL PRINTING" and address mentioning the notification number to "The Registrar, Lalit Narayan Mithila University, Kameshwaranagar, Darbhanga, Bihar 846008" and all the bids must reach on or before 02.01.2025 (by 4:00 p.m.). Bids received or submitted after the specified time will be rejected and no intimation will be sent in this regard.



- IV. A big envelope shall contain two envelopes; one marked as "Technical Bid" and other marked as "Financial Bid"
- V. Financial bid will only be opened if the firm qualifies the Technical bid
- VI. The Registrar on behalf of Lalit Narayan Mithila University, Kameshwaranagar, Darbhanga, Bihar reserves right to reject any or all offers received in response to tender or cancel or withdraw the tender notice without assigning any reason, whatsoever.
- VII. The bidder must enclose a copy of GST Certificate, PAN Card, Income Tax Clearance Certificate and last 03 years Financial Statement and all other details as required under eligibility criteria/ Technical bid.
- VIII. The Committee may disqualify bids on account of the following reasons:
  - If received after the last date and time.
  - If the bidder disregards any of the terms and conditions of the bid.
  - If the participants attempts to influence any member of the selection committee
  - Receipt of Conditional bids
  - The decision of the Committee in the matter of disqualification shall be final and binding and no further correspondence shall be entertained from the disqualified bidders thereafter.

### IX. Termination of the bid

Against all expectation entertained by Lalit Narayan Mithila University, Kameshwaranagar, Darbhanga, Bihar if none of the participating firms could be declared by the Committee as the winner of the bid, the bidder will be regarded as terminated.

X. **Penalty Clause:** Company/firm should maintain safety, accuracy, confidentiality and secrecy while executing the job. For any laps in security, inaccuracy or mishandling/misuse, if any, penalty equal to 100% of the contract will be terminated

### 5. Payment:

Payment will be made to the firm after receipt of bill dully verified by the Controller of the Examination's office and after successful and satisfactory work by the firm.
