Part B

CURRICULAR ASPECTS

1.1 - Curriculum Design and Development

1.1.1 - Curricula developed and implemented have relevance to the local, national, regional and global developmental needs which is reflected in Programme outcomes (POs), Programme Specific Outcomes(PSOs) and Course Outcomes(COs) of the Programmes offered by the University

In the Universities of Bihar, the Syllabi of the various Programs are framed from time to time by the Chancellor's secretariat. Accordingly the present revised Syllabi under CBCS have been finalized by the Chancellor's Secretariat taking the key contents of Model Syllabus of the UGC in different subjects. Having liberty to change 20% syllabi, we at University have incorporated the matters relevant to regional needs which were approved by the Academic Council of the University before its implementation from the AY 2018-19. In taking such change, feedback from students, teachers, alumni and employer were also considered by the University.

The present Syllabi under CBCS have relevance to the local regional, national and international developmental needs. Issues related to poverty, socio-economic issues, gender, environment and climate change, livelihood, entrepreneurship, technology and innovations, mental health, state welfare schemes, local economy and preservation of regional languages are included in the curricula. Especially we give focuses on regional/local developmental needs. The Syllabi of 12 subjects include projects and field works to encourage students to work on real life situations, and to explore field applications with commercial feasibility.

For research programs, the UGC PhD Regulations-2016 was notified by the Chancellor's Secretariat in 2017 for Universities of Bihar. The PhD Coursework Syllabi have also been revised and implemented by the University from 2021 onwards.

1.3 - Curriculum Enrichment**1.3.1 - Institution integrates crosscutting issues relevant to Professional Ethics, Gender, Human Values, Environment and Sustainability into the Curriculum**

The University offers postgraduate programmes under CBCS system. Students are offered Ability Enhancement courses, Skill Enhancement Courses and Generic Elective courses besides the Core Courses. These courses specifically address issues of Gender, Human Values, Professional Ethics and, Environment and Sustainability. In the first semester AECC1 includes Environment Sustainability and Swachh Bharat Abhiyan of three and two credits respectively. In the second semester, a range of optional courses like Environmental Law, Yogic Sciences, Computers and IT of five credits are offered as AEC. In the third semester the syllabus includes AECC II of 5 credits on Human Values, Professional Ethics and Gender Sensitization. In the fourth semester, a GEC of five credits on Human Rights is offered to the students.

The University offers some specialized courses like one year PG Diploma Course in Geriatric Care and a certificate course in women's studies and Foreign Languages. These programmes are specifically designed to address the issues of Gender and Human values.

Apart from these, the syllabi of different postgraduate programmes are so designed as to incorporate and address the issues related to Gender, Human Values, Professional Ethics, and Environment and Sustainability.

2.2 - Catering to Student Diversity

2.2.1 - The institution assesses the learning levels of the students and organises special Programmes for advanced learners and slow learners

Advanced learners are encouraged to make poster and PPT presentations. Student seminars and symposiums are regularly organized. Advanced learners are motivated to take part in inter-university competitions. They are provided e-links of e-pathashala, MOOCs on SWAYAM, NPTEL, NDL, Spoken Tutorial portals for listening to lectures on advanced topics. Advanced learners are informed about competitive exams and career pathways such as CSIR/UGC NET, GATE, BARC, DRDO etc. They are advised to go through standard reference books in the departmental/central library. They are encouraged to write model answers based on the University question paper. Advanced learners are given opportunity to anchor the sessions during departmental seminar/conferences.

For Weak Learners, remedial classes/ difficulty sessions/ extra and special classes are taken regularly. Detailed feedback is given to weak learners on their performance in tests and discussions, semester exams/ practicals etc. Peer teaching is employed by having advanced learners teach a few topics assigned for the benefit of weak learners. Students are taught test taking strategies. Teachers help slow learners by administering test

questions and assignments periodically. Consequent upon COVID-19 pandemic, University departments have organized online classes separately for both advanced learners and slow learners during holidays and vacations. This practice is initiated as a part of blended learning system for the students having different learning capabilities

2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problem-solving methodologies are used for enhancing learning experiences

The University provides a variety of learning experiences for better understanding and implementation of the subjects as a part of their life.

- Students are trained for theoretical as well as practical learning.
- Educational trips for students are arranged which facilitate observation and collection of data and specimen related to the subject, such as visits to forest areas, fish farms, agro parks, legislatures, industries and national laboratories of repute etc.
- Students participate in group discussions /mock interviews to improve their communication skills.
- Students are involved in interactive learning, problem-solving exercises, group discussions, seminars, paper presentations, quiz competitions, workshops, role-play, etc.

The learning experience is upgraded by extensive use of ICT tools such as PPTs, LCD, interactive boards by teachers, especially consequent to the COVID-19 pandemic and evaluated through mock tests, quiz, and online testing. Learning is made student-centric through project work, seminar presentations, and assignments. Students often volunteer in conferences, seminars and workshops. Students are motivated to register on portals of e-learning like SWAYAM, NPTEL, NDL, and Spoken Tutorials. The University Central Library provides internet facilities, access to texts, reference books, Educational CDs and DVDs. Moreover, projects, field-works, seminars, excursions, NSS, NCC etc. inculcate among the students the practice and habit of participative learning and problem-solving methodologies.

2.3.2 - Teachers use ICT enabled tools including online resources for effective teaching and learning processes during the year

Notwithstanding the Covid-19 Pandemic and the Lockdown since March 2020, student mentoring and academic counselling was facilitated and continued by online strategies quite remarkably and successfully. The pandemic provided opportunities to the teachers to learn, adopt and practice the ICT enabled tools. The use of mobile phones, laptops and their integration with online teaching learning platforms became a common practice for both teachers as well as students. The IQAC of the University conducted Faculty Training Programme/ workshop for the development of e-content and the use of e-resources during the year. Faculty are enriched through training workshops on digital tools, online portals such as National Digital Library, SWAYAM, etc. The e-resources in various subjects in the form of PPTs, PDF, digital material, and video lectures links have been created and uploaded on the university website. Teaching learning using LCD projectors were conducted through offline, online and blended mode through out the year. Use of ICT by incorporating audio-visual material makes lessons visually interesting, positively impacting both the learning outcomes of students and their attendance. Almost all teachers are now comfortable with online platforms such as Google classroom, Google Meet, ZOOM, Webex, MSTeam to implement 'flipped learning', posting and receiving assignments, post educational resources and materials for teaching learning and evaluation.

The University has an Examination Data Centre which is the dedicated for student registration, generation of examination roll numbers and admit cards, allocation of examination centres, entry and comparison of marks entered by two

different tabulators, preparation and publication of results, provisionals and certificates. The Examination Data Centre does registration and generates examination role number and print admit cards, allocates examination centres, prepares and publish results and certificates of different course of university as well as it Constituent/ Affiliated Colleges. The University's transparent and robust mechanism to conduct continuous internal assessment as per the CBCS guidelines adds to the academic enhancement of the students.

Stakeholders are informed about all the norms and directives through the University Prospectus that contains all the information on Academic Calendar and Conduct of Examinations. The Academic Calendar and Conduct of Examinations is communicated to the Faculty as well as students through Group Email or Whatsapp group messaging and is also uploaded on the University Website and the same are communicated to the heads of the Constituent and Affiliated Institutions/Colleges for the same. The University, for fair, equal and impartial response to all students in all spheres of work, including assessment and evaluation, has a dedicated Grievance Redressal Cell.

Attainment of PO, PSO & CO's is evaluated on the basis of both Continuous Internal Assessment and Semester Examinations defined for each course. Mapping of each question (both Continuous Internal assessment & Semester Examination that also include Assignment, Quiz, Seminar presentation, Viva-voce exam, Lab Work, Project work, Field Work

etc as per the syllabi) is carried out with the specific Course Outcome. Mapping of questions are also carried out that ensure the both Lower Order & Higher order of understanding/critical thinking in reference to the Course of study. Attainment level of Continuous Internal Assessment and Semester Examination by each student is then integrated using the defined procedure & formulae to analyse the attainment of the specific Course as per the defined Program Learning Outcome. PO, PSO & CO's aims to inculcate Personal enrichment, Social values, Gender equality and Professional ethics amongst students such that they can lead a respectable life

All PG Programmes have dissertation/project/Lab course to generate research interest among the students. The curricula of

all the programmes of the university clearly define research-oriented courses. The University also has a policy for promotion of the research with budgetary provision of SEED money for the faculties. It also incorporates incentive for the publication in SCOPUS/WOS/UGC-CARE list journals to enhance the research quality. These policies are also uploaded on the university website and are being properly implemented. To enrich academic research ecosystem, advanced research centre is under construction and it will be operational soon.

Total 71 research papers (SCOPUS-11 and WOS- 11) and 35 books/chapters were published by are faculties. Altogether 125 scholars were awarded PhD & 31 students qualified for the UGC NET/JRF exam. SERB- TARE grant was funded to a faculty member of chemistry and international fellowship award by Norwegian University to the faculty of Geography respectively, which shows their research competency and expertise in their field. e-Learning resources were also developed by the faculties for the benefits of the students.

INFRASTRUCTURE AND LEARNING RESOURCES

4.1 - Physical Facilities

4.1.1 - The institution has adequate facilities for teaching - learning, viz., classrooms, laboratories, computing equipment, etc.

The university's 201-acre campus is divided into administrative and academic units. The university offers adequate space for infrastructure, classrooms, research & computer laboratories. The Department council of the departments use the space for academic purposes. Various locations have been identified as suitable for construction of additional hostels for students and researchers, and residential quarters for professors and non-teaching staff. This has facilitated making the best use of available space in a planned manner ensuring the university's availability of open green spaces, management of natural lakes while retaining aesthetic beauty of historic buildings.

Departments have sufficient class rooms, laboratories, seminar halls and conference rooms equipped with audio-visual equipment

with LCD projectors. University Wi-Fi facility allows teachers, employees, and students to use the internet throughout the campus. LNMU has a 250-seat capacity Jubilee Hall and many smaller conference halls that are utilised for seminars, lectures, symposia, conferences, workshops, & drama activities.

The University Central Library has rich consolidated library resources with over 75000 books, as well as Wi-Fi enabled reading hall. In addition, the departments have subject-specific libraries with books on specialised themes, journals, volumes/periodicals. At the department level students have access to computers for academic activities.

The Sports and cultural wing of the University is well acknowledged. It offers a variety of sporting and cultural activities. Special attention is given to athletes qualifying minimum eligibility criterion. University has developed and maintained great sports facilities as well as a full-bodied infrastructure for cultural events and other extracurricular activities. The Director of Sports also serves as a nodal centre organising events, supervising and executing various sports activities. The new IT policy is crucial in establishing a conducive environment and providing a networked campus with accessible internet connectivity. The entire university campus has a Fibre Optic of ~4KM providing Wi-Fi connections to over 147 access points across the campus. Presently 100% campus is Wi-Fi enabled. The University offers essential ICT services including Internet Access, emailing, IT security, campus Wi-Fi, University Portal development and maintenance, problem diagnostics and troubleshooting etc. All ICT services remains operational 24x7 across the university campus. It administers a 20 Mbps link from National Knowledge Network to provide smooth internet facility. The university also reaps benefits from state government initiatives of Internet facility through free Wi-Fi under Bihar Viksit Bihar Mission. Besides, the university subscribes to an additional Internet bandwidth subscription of 200 Mbps available from other private operators. Key features such as anti-plagiarism services maintained by Library, online e-contents uploaded by Department of Distance Education, on-line admissions, fee payment etc. by examination branch is other essential services governed by IT policies. University's domain name @lnmu.ac.in has already been created for teachers, administrative and technical

staffs. In addition, University also offers outreach programs in live streaming mode in collaboration with IIRS-ISRO and similar live interactive learning facilities to the students.

For maintenance, the University employs a three-tiered system. The engineering section is in charge of the repair and maintenance of the University buildings, power supply and connections from the university's maintenance fund. The Estate Office is responsible for keeping track of the University's lands and buildings, as well as dealing with various processes for space distribution on campus. Services of caretakers are also taken to assist in the maintenance, preservation and upkeep of the lawns, gardens and lakes of university campus. Sports department is in charge of maintenance of sports complex and Stadium etc where under the Annual Coaching Plan, mentoring and ground services in the form of football field and kabaddi ground made available to the students.

The sports complex has a well-maintained gymnasium with modern fitness equipment, table tennis practice hall. The maintenance of infrastructure is done through both engineering section as well as at individual department level. The entire University is enabled with air-based Wi-Fi network connected through an optical fibre cable and providing network to all 21 PG departments and administrative offices. The ICT enabled classrooms at departments are reaping benefits of high-speed Wi-Fi connectivity to conduct various online programmes like outreach programmes, invited lectures as well as conduct of virtual nation and international conferences

The Bihar State Universities Act of 1976 emphasizes democratic functioning and participative administration of the universities of Bihar. It provides for several Statutory Committees dealing with respective academic and/or administrative areas. Proper representation of faculties and officers is ensured in these committees so that things can be decided with broad academic interests and those decisions can get implemented effectively too. In addition to these statutory committees, Section 17 of the B S U Act, 1976 provides for the constitution of various Authorities of the University like the Senate, Syndicate, Academic Council, Faculty, and a host of others. These authorities comprise both elected representatives of the teachers, non-teaching staff, and students as well as the members from different areas of life nominated by the Chancellor/the State Government. These authorities consider the recommendations of the relevant statutory

committees and take proper decisions in this regard. They oversee and review the timely and effective execution of these decisions as well. It is the responsibility of the officers of the university to ensure the proper execution of such decisions taken by different authorities of the university. Section 7 of the B S U Act, 1976 defines the powers and functions of the different officers of the university. Such institutional provisions and practices are intended to make the governance of the university completely communitarian. These are perceived to increase participation and involvement, and give voice to more and more people in the administration of the university.

6.2.2 - The functioning of the institutional bodies is effective and efficient as visible from policies, administrative setup, appointment and service rules, procedures, etc.

The administrative setup, appointments and service rules of Lalit Narayan Mithila University are as per provisions of the Bihar State Universities Act, 1976 (amended up to date). The Chancellor is at the helm of affairs and the Vice-Chancellor of the University is vested with administrative, academic and financial powers. The role and responsibilities of the Vice-Chancellor are well defined in the Act and related statutes. The VC is the Principal Executive and Academic Officer of the University.

Besides, the University has Statutory Committees like -Anti Ragging Committee, Internal Complaint Committee and others for day-to-day functioning.

The Government of Bihar plays key role in appointing teaching and non-teaching personnel. The University identifies vacancies and makes requisitions for various posts from time to time. Selections are made through Selection Committee/Bihar Public Service Commission/The Bihar State University Service Commission (BSUSC) through nationwide advertisements in conformity with the spirit of Article 14 and 16 of the Constitution. On the recommendation of the Commission, University appoints them with the due approval of the State Government.

To meet the exigency, the University is authorized to appoint Guest/Part-Time Teachers purely on temporary basis for 11 months in accordance with the University Laws.

6.4 - Financial Management and Resource Mobilization

6.4.1 - Institutional strategies for mobilisation of funds and the optimal utilisation of resources

The annual budget is prepared by the Finance Committee and is approved by the competent bodies of the University. Finally it is sent to the State Government for approval and release of grant-in-aid. For proper utilization of the funds, there are monitoring committees at different levels. For effective monitoring and

efficient use of grants provided by the UGC/RUSA for construction, the Building Development Committee scrutinizes and sanctions the proposed projects. There is a complete transparency in the policies of allocation and utilization of funds. Gem portal is extensively used for the institutional bulk purchases.

The grants received from the state government form the major chunk of resources. The receipt from fees from regular courses as well as self-finance courses and leasing of ponds and mango orchards are the principal internal resources to mobilize the fund for the University. Besides, the University generates income from renting out the multipurpose hall, Jubilee Hall, Guest house, canteen, Post Office, Bank etc. The affiliation fee from the affiliated colleges is also one of the sources of revenue for the university.

Various cost cutting measures have been taken to manage the shortage of resources. Managing with the outsourced employees and lowering down academic and administrative expenses by holding PhD viva voce through Video Conferencing, conducting webinars etc

Audit at the level of Government has been currently going on and the report is yet to be submitted by the Audit team.

The University Audit Committee is empowered to examine the auditor's report and if required, may seek explanations from the controlling and disbursing officers. The auditor's report together with the report of the University Audit Committee is submitted to the Senate and the State Government for such action as they think fit.

6.5.1 - Internal Quality Assurance Cell (IQAC) has contributed significantly for institutionalizing the quality assurance strategies and processes by constantly reviewing the teaching learning process, structures & methodologies of operations and learning outcomes at periodic intervals

L N Mithilla University has institutionalised the following two, among others, quality enhancement strategies of IQAC:

1. IQAC has mapped out the learning outcome of Syllabi of all the programmes offered by the University. The use of ICT in delivering lectures has significantly enhanced. Integrated Learning Management System (ILMS) proposed by the IQAC is now being synergised and within a year it shall be fully functional. Students have been asked to give their feedback/suggestions on course content and its delivery so that it can be strengthened further.

2. Regular seminars/workshops to hone the calibre of students and faculty have become an institutional practice. As many as 61 National Seminars and 12 International Seminars were organized by the various PG Departments in blended mode. IQAC has been consistently and actively involved in motivating the faculty and the university administration. With its initiative, the University agreed to provide a grant of Rs. 20,000/- for each such event.

In the university campus, dustbins of three different colors- Blue, Red and Green have been placed for the management of waste material as well as the cleanliness and upkeep of the campus. The dustbins are marked with proper instruction- Blue colored dustbin for disposing dry garbage and degradable waste, Green dustbin for disposing recyclable waste and Red dustbin for general household waste. These dustbins are emptied at 06 am and 06 pm everyday. The university campus has a facility to convert organic waste into manure by the process of vermin-composting. The manure thus

obtained is used for the nurturing of plants and trees inside the campus. The waste material that cannot be converted to manure is collected by Darbhanga Municipal Corporation regularly.

Lalit Narayan Mithila University has an added advantage of having several ponds and water bodies. These water bodies help in the natural recycling of much of the liquid waste from the campus. For Grey water there is a proper drainage system.
